2024 SASKATOON GUN SHOW RULES - PLEASE READ!

1. Restricted firearms on display must be locked in a display case. Non-restricted rifles and shotguns shall have a cable or chain passed through the trigger guards or be rendered inoperable by a secure locking device. Tie wraps are acceptable.
2. No firearm is to be delivered to any person, unless they are in possession of a valid Firearms Acquisition Certificate, Firearms License, or Firearms Business License and can legally take possession having complied with Firearms Legislation and Regulation.
3. No person under the age of 18 may purchase firearms or ammunition. All ammunition shall be inaccessible to the general public.
4. No firearm is to be handled without the express consent of the owner or businessperson.
5. No person shall show or display a loaded or primed firearm or air-gun. Nor shall any exhibitor or any person place any charge, be it blank or ball or empty case, percussion cap, tube pill or any other device upon any firearm, air-gun or bow within the show premises.
6. No live ammunition shall be displayed which can be chambered in any firearm in the same exhibit except when locked in a separate display case **or visibly sealed**.
7. All firearms on display shall be supervised by a person, at least 18 years of age, qualified to possess such firearms.
8. All Gun Show exhibitors shall be fully responsible for their display at all times.
9. **All Exhibitors and their helpers must wear their exhibitor ribbons** at all times during the show and the show set-up. This enables security to identify persons who should not be in the building during set-up.
10. Absolutely NO black powder, fireworks or other potential explosives allowed on the show premises.
11. All exhibitors are expected to be on time for the show and remain until the closing time of the show. Exhibitors must not remove their exhibits during the continuance of the exhibition.
12. **All firearms sold or delivered to members of the public must be accompanied by a signed bill of sale.**
13. **All members of the public bringing firearms to the show must have these firearms inspected to see that they are unloaded and tagged at the door by Show Personnel.**
14. **Members of the public leaving the show with firearms must have these firearms and their bill of sale examined by Show Personnel.**
15. In addition to the above conditions, Exhibitors must comply with all Federal and local laws pertaining to firearms, ammunition, components, and business permits.
